Since much of their time is volunteered we want to recognize their unselfish desire to help our youth of today to become our future firefighters of tomorrow.

Criteria:

- Must be a member of the cadet section at the time of nomination
- Must be an advisor with a HHEC'Ecf gv'Rtqi tco 0
- Must be over the age of 21 and not registered as a fire rescue cadet in the last 12 months

Nomination Process:

- Be nominated by an individual who completes the nomination form online (www.ffca.org) or attached.
- Submit a summary of his/her service to the fire rescue cadets
- Submit any supporting documentation such as awards, letters, or special recognitions that demonstrates this individuals support for this youth program
- Nomination form and all supporting documents submitted prior to deadline
- Winner will be chosen by a committee consisting of a minimum of 3 members of the cadet section along with the section chair or vice chair.
