FASAR Program Directives discussion - discussion took place about the program directives. Comments expressed this was a good idea (Ed Dwyer), Recommended to change the name to a General Memorandum instead of a Program Directive (Pete Gomez, Dave Downey). The General Memorandum will provide a transparency and historical documents that will be stored at the FFCA FASAR section website.

US&R Hurricane ConOp – The document is still under draft. SFM, FWC, FFS and FASAR are providing positive feedback. FASAR will schedule a meeting with Wayne Watts to continue the discussion.

EMAP Mission Ready Package cost estimate Template completion – New MRPs to be sent out to each task force to complete pre-storm to establish base line of deployment costs.

SFM report – John Kohnke reported on the status of the FY15, FY16 and discussion on States DSOC meetings

Administrative Rule – Scott Chappell reported that there was a need to request for the rule to be opened to add and delete verbiage to update the rule.

Work Group report –

Communications – Scott Chappell reported working with the state work group on the MARC unit to organize comms planning. More to come.

Water Rescue - Larry Doerffel reported on the status of the work group. Jeff Strickland advised that the FEMA US&R Program has developed a Water ConOP. The work group will review. Task books for water rescue and boat operations are also published through FEMA US&R. The work group will review and are task to create a draft Water Rescue ConOp to present to FASAR at FRE 2018.

ADSAR - Scott Chappell reported on the ADSAR (UAV) subgroup. FSU has entered into an agreement with FL-TF8 to develop a UAV ConOp.

No other active work group reports presented.

Statewide hurrex 3rd week of May report – Scott Chappell reported considering a new concept. Would like to pre-identify SEOC staffing and provide training between FRE and HurrEx. Integrate the HurrEx and the US&R Exercise. During that exercise incorporate the task forces, SEOC 4/9, and other partners to better coordinate the training in more a holistic approach.

Task Force reports -

Task Force 1 – Advised of an air ops drill conducted with TF2, USAF, and other federal and state resources loading a partial cache and 70 personnel on a C17 from Homestead AFB and movement to MacDill AFB – Key West Naval Air Station – and back to Homestead AFB. Exercise went well. Caused additional discussion about the need to consider Title 10 assets for the Key West Re-Entry plan.

Task Force 2 – No report echoed TF 1

Task Force 3 – Conducted MobEx that went well. Working on training new personnel

Task Force 4 – No report

Task Force 5 – Reported they just received a conditional certification from Emergency Management Accreditation Program as a type I asset under the new ANSI EMAP 1-2016 National US&R Standard.

Task Force 8 – Reported they have entered into an agreement with FSU on the UAV project. Continue routine training.
